

RULES OF ACCESS AND CONDUCT ON THE CROCUS EXPO INTERNATIONAL EXHIBITION CENTRE TERRITORY.

1. The Crocus Expo International Exhibition Centre (hereinafter referred to as Crocus Expo) territory includes pavilions, outdoor areas at pavilions used for organization and holding of events and also indoor and outdoor free parking lots (hereinafter referred to as the Crocus Expo territory).
2. Opening hours of pavilions during Events period are from 08:00 to 20:00 unless otherwise specified by the Crocus Expo administration.
3. Visitors are admitted to the pavilions through metal detector frames at the entrance groups and after inspection of hand-carried luggage and personal belongings by representatives of the security service.
4. When passing through the central entrances and metal detectors into the Crocus Expo pavilions, visitors can carry hand luggage (weight maximum 20 kg, dimension maximum 60x60x60 cm for a total of 180 linear cm) accessible for inspection by representatives of the security service. Hand-carried luggage includes: handbags, briefcases, suitcases, backpacks, outerwear and strollers. Items not related to hand-carried luggage: equipment of any kind and purpose; furniture items and components; boxes; packaging materials; items and materials for decoration (banners, posters, balloons, plants, etc.); advertising structures; exhibits of any size, quantity and type of packaging to be exhibited are allowed to be carried only through the loading gates in the Materials Handling areas (access by vehicle passes).
5. While on the Crocus Expo territory, visitors shall observe and comply with the requirements of public order, safety rules, established sanitary and epidemiological standards, the requirements of the Crocus Expo employees and representatives of the security service.
6. Any photo, movie, video, TV shooting shall be carried out on the Crocus Expo territory only if approved by the Crocus Expo administration.
7. Access to the Crocus Expo territory may be limited in order to ensure the safety of visitors.
8. In the event of an emergency on the Crocus Expo territory visitors are obliged to comply with the requirements of the Exhibition Centre employees and representatives of the security service.
9. Visitors should immediately inform the Crocus Expo employees or representatives of the security service about detection of abandoned or suspicious items on the Crocus Expo territory.
10. Crocus Expo shall not be liable for harm to life and health received by the visitor as a result of violation of these Rules, safety rules, in case of non-observance of precautions and in case of other careless or imprudent actions of the visitor himself.
11. Material damage caused to Crocus Expo by a visitor shall be compensated in accordance with the procedure established by the legislation of the Russian Federation.
12. It is prohibited on the Crocus Expo territory:
 - to enter premises and other areas closed for free admittance; use service and technological entrances, elevators, etc.;
 - to smoke tobacco and consume nicotine-containing products in buildings and in the outdoor area, with the exception of specially designated places on the Crocus Expo territory;
 - to leave children unattended;
 - to do anything which might endanger the Crocus Expo property, might be hazardous to life and health of the people on the Crocus Expo territory; or might be a source of obstacles or violations in ensuring safety;
 - to inscribe, post and distribute printed products of information or advertising content, conduct propaganda activities;
 - to be under the influence of alcohol, drugs and intoxication;
 - to be in dirty clothes; engage in begging, pollute and litter the Crocus Expo territory;
 - to move inside pavilions on bicycles, scooters, roller skates and other similar transport and sporting equipment;
 - to bring pets, except guide dogs accompanying visually impaired persons (if there is a document confirming the special training of the dog, issued in the form established by the order of the Ministry of Labour and Social Protection of the Russian Federation No. 386n dated June 22, 2015);
 - to obstruct the performance of official duties by the Crocus Expo employees and representatives of the security service, not to fulfil their requirements for compliance with the Rules herein, maintenance of public order and ensuring access control.
13. It is prohibited to bring to the Crocus Expo territory:
 - any types of firearms, gas and cold steel arms, ammunition, sharp/cutting objects;
 - explosive and flammable substances, flammable materials, pyrotechnics of all kinds, as well as substances that have a pungent odor, poisonous, caustic and toxic agents;
 - alcoholic beverages, narcotic and psychotropic drugs, as well as their consumption;
 - things (objects and means) that can damage or contaminate the pavilions, as well as stain the things of other visitors.

RULES OF VISITING EVENTS HELD AT THE CROCUS EXPO INTERNATIONAL EXHIBITION CENTRE.

1. Event is an exhibition, fair, corporate, congress or other event held on the Crocus Expo territory organized by either Crocus Expo or another person who has entered into relevant contract with Crocus Expo.
2. When visiting events the visitors shall observe and comply with rules and regulations established by the Organizer including those related to admittance procedure and documents approved for admittance (e-tickets; tickets purchased at ticket offices; invitations, etc.), the opening hours of the event, restrictions, etc.
3. Visitors may be refused the access to the event or may be demanded to leave the aforementioned event without any refund for bought tickets in the following cases:
 - in the absence of the entrance ticket/invitation to the event;
 - at refusal to undergo personal inspection and inspection of hand-carried luggage and personal belongings;
 - in case of being in a state of alcoholic, narcotic or any other intoxication;
 - in an attempt to enter the Crocus Expo territory with objects prohibited for bringing;
 - at performance of actions violating the public order;
 - at non-observance of requirements of the Rules and requirements of the Crocus Expo employees or representatives of the security service.If necessary, the violators of the public order and safety requirements can be transferred to law enforcement officers.
4. There might be certain age restrictions on access to events held at Crocus Expo. For information about such restrictions, please refer to official web sites and event announcements. Children under 14 years of age are admitted to visit events only accompanied by adults
5. It is not advisable to have outerwear on provided there are cloakrooms available when visiting events. Cloakroom opening hours and rules are indicated on the information plate by the cloakroom
6. With a view to ensure the protection of copyright, other intellectual property and related rights, any photo, movie, video and TV shooting, any kinds of audio recording of the event may be prohibited or restricted by the Organizer
